4. Commissions

- Affiliates will earn a commission of **30% of the sales price** for every sale generated through their affiliate link.
- The sales price will vary depending on the specific product or subscription sold.

- Commissions will only be paid after the purchase is completed and the customer has not requested a refund within the specified refund period.
 - If a refund is issued within the refund period, no commission will be paid for that sale.
 - Commissions will be paid on a monthly basis, with **no minimum payout threshold**.
 - We reserve the right to withhold or reverse commissions in cases of fraudulent or questionable transactions.

5. Payment

- Commissions will be paid via the payment method of your choice (e.g., Gift card, UPI, PayPal, Direct bank transfer).
 - Payments will be made in the currency of your choice as per your preferences.
 - Affiliates are responsible for ensuring their payment details are accurate and up to date.
 - Affiliates are solely responsible for any taxes associated with their commission earnings.

6. Term and Termination

- This agreement will begin upon our acceptance of your affiliate application and will remain in effect until terminated by either party.
 - Either party may terminate this agreement at any time, with or without cause, by providing written notice to the other party.

 - We reserve the right to terminate your participation immediately if you breach these terms, including engaging in deceptive marketing practices or promoting competing products alongside MyRealProduct.

- We may modify any of the terms and conditions of this agreement at any time at our sole discretion. Modifications may include, but are not limited to, changes in commission structure, payment procedures, or program rules.
 - If any modification is unacceptable to you, your only recourse is to terminate this agreement. Your continued participation in the program following the posting of the new terms will constitute your acceptance of the changes.
